THIS INDENTURE, Made this 4/29/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and CP-SRMOF II 2012-A Trust, by U.S. Bank Trust National Association, not in its individual capacity but solely as Trustee, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1202258CV, Klamath County Sheriff's Office Number J13-0066, in which Wells Fargo Bank, NA was plaintiff(s) and Timothy E. Dahm A/K/A Timothy E. Dahm II A/K/A Timothy E. Dahm III; State of Oregon; United States of America; and Occupants of the Premises was defendant(s), in which a Writ of Execution, which was issued on 6/7/2013, directing the sale of that real property, pursuant to which, on 10/21/2013 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$110,000.00, to Wells Fargo Bank, NA, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 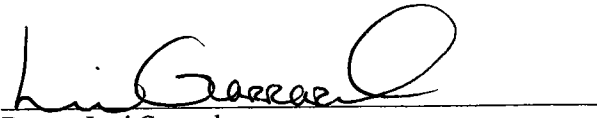

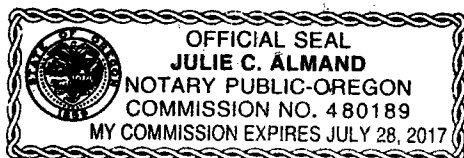

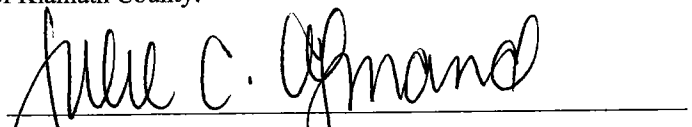
