THIS INDENTURE, Made this 5/12/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Nationstar Mortgage LLC, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1204587CV, Klamath County Sheriff's Office Number J13-0098, in which Nationstar Mortgage LLC was plaintiff(s) and Bobby R. AND COMMONLY KNOWN AS 4903 LORRAYNE PLACE, KLAMATH FALLS, OREGON 97603

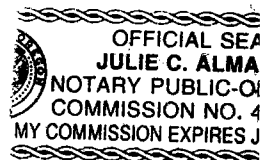

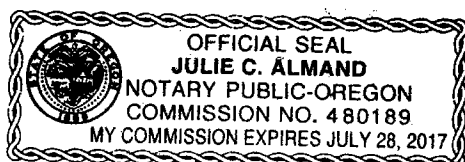


