RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1301526CV, Klamath County Sheriff's Office Number J13-0105, in which Wells Fargo Bank, NA was plaintiff(s) and Eric David Markum; Holliday Jewelry; Midland Funding, LLC; Miss Muffetts Learning Center, other Persons or Parties, including Occupants, Unknown Claiming any Right, Title, Lien, or Interest in the Property Described in the Complaint Herein was defendant(s), in which a Writ of Execution, which was issued on 8/16/2013, directing the sale of that real property, pursuant to which, on 11/1/2013 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$138,631.50, to Wells Fargo Bank NA, who was the highest and best bidder, that sum being the highest and best sum bid therefore. TO HAVE AND TO HOLD the same unto the grantee and grantee's heirs, successors, and assigns forever.

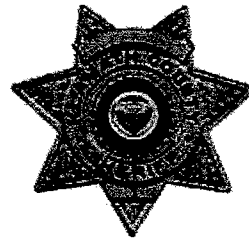

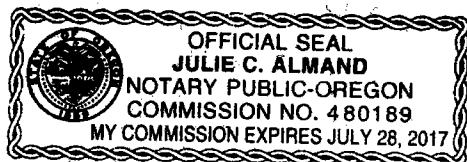


