To Have and to Hold the same unto grantee, and grantee's heirs, successors-in-interest and assigns forever.

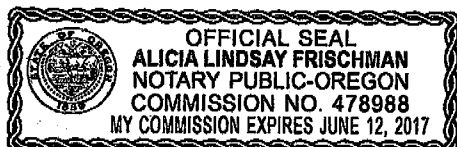
