RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1300379CV, Klamath County Sheriff's Office Number J13-0097, in which Midfirst Bank, through its loan servicing agent Midland Mortgage, a Division of Midfirst Bank was plaintiff(s) and Tracy O. Mulkey; Tammy S. Mulkey; Occupants of the Property was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 8/15/2013, directing the sale of that real property, pursuant to which, on 10/25/2013 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$149,688.00, to Midfirst Bank, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 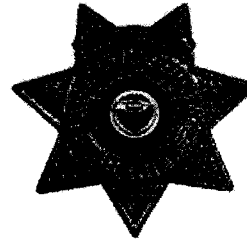

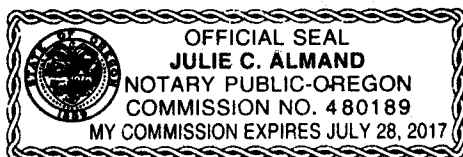


