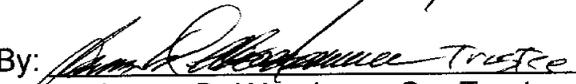
Lot 21, Tract 1278, COLLIER LANE, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

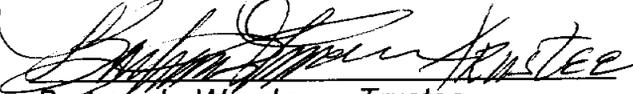
Subject to the existing mortgage, easements, covenants, restrictions, and rights of way of record, if any.
