LEGAL DESCRIPTION

PARCEL 1 - TAX LOT R2407-680-600

That portion of Government Lots 15 and 16 of Section 6, Township 24 South, Range 7 East, of the Willamette Meridian, Klamath County, Oregon lying southwesterly of Oregon State Highway #58.

Together with that portion of the southeast quarter of the northeast quarter (SE1/4NE1/4) of Section 1, Township 24 South, Range 6 East of the Willamette Meridian, Klamath County, Oregon, as shown in Property Line Adjustment PLA 13-12, Klamath County, and more particularly described as follows:
