

THIS INDENTURE, Made this 5/14/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Max Profits Inc., hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1302051CV, Klamath County Sheriff's Office Number J13-0095, in which Bayview Loan Servicing, LLC was plaintiff(s) and Chris L. Rookstool, et al was defendant(s), in which a Writ of Execution of Real Property, which was issued on 8/30/2013, directing the sale of that real property, pursuant to which, on 10/18/2013 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$60,001.00, to Max Profits Inc., who was the highest and best bidder, that sum being the highest and best sum bid therefore.
