EXHIBIT "A" LEGAL DESCRIPTION

Lots 16 and 17 in Block 6 of WOODLAND PARK, together with an undivided 2/88 interest in the following described land, 2 parcels situated in Government Lots 1 and 2, Section 15, Township 34 South, Range 7 East of the Willamette Meridian and being more particularly described as follows:

PARCEL 1:
