

EXHIBIT A

Real property in the County of Klamath, State of Oregon, described as follows:

A parcel of land situated in the S1/2 SW1/4 NW1/4 of Section 11, Township 39 South, Range 9 E.W.M., more particularly described as follows:

Beginning at a point on the East-West quarter line which lies North 88°57' East a distance of 477.0 feet from the iron axle which marks the quarter section corner common to Sections 10 and 11, Township 39 S., R. 9 E.W.M., and running thence: continuing North 88°57' East along said East-West quarter line a distance of 67.5 feet to an iron pin; thence North 1°12' West parallel to the West section line of said Section 11, a distance of 331.4 feet; thence South 88°57' West parallel to the East-West quarter line a distance of 67.5 feet to a point; thence South 1°12' East a distance of 33.4 feet, more or less, to the point of beginning.

Saving and Excepting therefrom a strip of land 30 feet wide along the Northerly side of said tract reserved for road purposes.
