THIS INDENTURE, Made this 4/29/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and PennyMac Loan Services, LLC, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1300364CV, Klamath County Sheriff's Office Number J13-0096, in which JPMC Specialty Mortgage LLC F/K/A WM Specialty Mortgage LLC was plaintiff(s) and Sandra L. Nyback Smith AKA Sandra Smith; Klamath County; Oregon Affordable Housing Assistance Corporation, other Persons or Parties, including Occupants, Unknown Claiming any Right, Title, Lien, or Interest in the Property described in the Complaint herein was defendant(s), in which a Writ of Execution, which was issued on 06/24/2013, directing the sale of that real property, pursuant to which, on 10/18/2013 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$341,113.53, to JPMC Specialty Mortgage LLC F/K/A WM Specialty Mortgage LLC, who was the highest and best bidder, that sum being the highest and best sum bid therefore.
