JURISDICTION AND VENUE

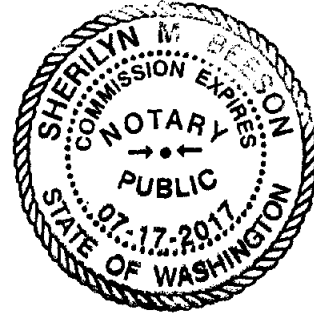
