According to the provisions of ORS 368.341(3) and ORS 368.351, a petition containing the acknowledged signatures of the owners of over 60% of the property abutting the public property described in Exhibit "A", included hereto and by this reference incorporated herein, was submitted, indicating said owners approval of the proposed vacation was filed with the Klamath County Public Works Department and accepted by the Board of County Commissioners on 7/16/13.

Thereafter, the Public Works Department filed with the Board of County Commissioners a written report containing the information required by ORS 368.346(1). According to ORS 268.401 notice of a public hearing was provided and a hearing was held at 9:30am on 7/1/14.

Now, after fully considering the road officials report, testimony given during the hearing and other documentation presented, the Board of County Commissioners find that the vacation of Five Mile Creek Road, as described in Exhibit "A", is in the Public interest and finds that the petition should be granted. This order stipulates that the vacation is made subject to the rights of existing utilities to access, construct, maintain and operate facilities in the vacated area. Current and future owners of the vacated property shall keep the area free from brush, trees, structures and other hazards which might interfere or impede the operations of the currently existing utilities. A list of Pacific Power's facilities is included hereto as Exhibit "B" and by this reference incorporated herein.

NOW, THEREFORE IT IS HEREBY ORDERED that the petition is granted and that the portion of Five Mile Creek Road described herein is vacated. It is further ordered that pursuant to ORS 365.366(1)(d) the vacated property is vested in the owners of the abutting property by extension of their property boundaries.
