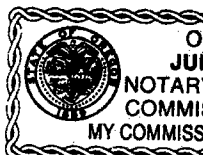

THIS INDENTURE, Made this 8/4/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1300725CV, Klamath County Sheriff's Office Number J13-0112, in which Everbank was plaintiff(s) and Connie M. Goddard; William M. Coomes; Wendy R. Coomes, other persons or parties, including occupants, unknown claiming any right, title, lien, or interest in the property described in the complaint herein was defendant(s), in which a Writ of Execution, which was issued on 10/3/2013, directing the sale of that real property, pursuant to which, on 12/16/2013 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$117,961.32, to Everbank, who was the highest and best bidder, that sum being the highest and best sum bid therefore. AND MORE COMMONLY KNOWN AS 6908 TEAL DRIVE, BONANZA, OREGON 97623.

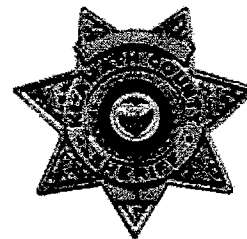
