# EASEMENT, RIGHTS-OF-WAY, AND PERMIT ASSIGNMENT AND ASSUMPTION AGREEMENT

THIS EASEMENT, RIGHTS-OF-WAY, AND PERMIT ASSIGNMENT AND ASSUMPTION AGREEMENT, is dated effective as of September 1, 2014, and is made between and among BEND CABLE PROPERTIES, INC., an Oregon corporation (formerly known as "Bend Cable Communications, Inc." and sometimes appearing of record under such name), BEND CABLE COMMUNICATIONS, LLC, an Oregon limited liability company (also sometimes appearing of record as "Bend Broadband" or "BCC, LLC"), and BENDBROADBAND VAULT, LLC, an Oregon limited liability company (collectively "Assignors" and each an "Assignor"), and TELEPHONE AND DATA SYSTEMS, INC., a Delaware corporation ("Assignee").

### RECITALS

- A. Each Assignor is a Grantee (either named or by assignment) under one or more of those certain easements, rights-of-way, and real property licenses and permits, identified on attached **Exhibit A** (collectively, the "Recorded Easements, Rights-of-Way and Permits").
- B. Each Assignor desires to assign to Assignee, to the extent of such Assignor's interests therein, all right, title and interest in and to the Recorded Easements, Rights-of-Way and Permits, and further assign to Assignee each Assignor's right, title and interest in any and all Other Easements, Rights-of-Way and Permits (as that term is defined below), whether or not such interest is evidenced in writing or of record, and Assignee desires to assume all of Assignors' right, title and interest in and to the Recorded Easements, Rights-of-Way and Permits and any and all Other Easements, Rights-of-Way and Permits.

NOW, THEREFORE, in consideration of the mutual agreements hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which are acknowledged by each of the parties hereto, the Assignors and Assignee agree as follows:

#### **AGREEMENT**

1. Assignment. Each Assignor hereby assigns and conveys to Assignee, its



successors and assigns, as of the Closing Time, all of Assignor's right, title and interest in and to the Recorded Easements, Rights-of-Way and Permits and all of Assignor's right, title and interest in any and all Other Easements, Rights-of-Way and Permits, whether or not such interest is evidenced in writing or of record. As used herein, the term "Other Easements, Rights-of-Way and Permits" means such easements, rights-of-way and real property licenses and permits (if any), owned or held by Assignor, by express grant or prescription, whether or not listed on attached Exhibit A, pertaining to the cable television system and other telecommunications facilities and assets conveyed by Assignors to Assignee, but only to the extent such Other Easements, Rights of Way and Permits constitute "Transferred Assets" under that certain Asset Purchase Agreement dated May 1, 2014, between Assignors, Assignee and certain other "Seller Parties" identified in such Asset Purchase Agreement ("Purchase Agreement"). Notwithstanding anything in this Section 1 to the contrary, the parties acknowledge and agree that to the extent that any of the Recorded Easements, Rights-of-Way and Permits or Other Easements, Rights-of-Way and Permits contain easement rights or other rights, permits or licenses that are Excluded Assets as defined in the Purchase Agreement, such easement rights, permits other rights and licenses are reserved by the applicable Assignor and excepted from this assignment and conveyance and shall not be deemed to be a part of this assignment and conveyance.

- 2. <u>Assumption</u>. Assignee hereby accepts the foregoing assignments and, in consideration thereof, Assignee hereby covenants and agrees that, on and after the Closing Time (as defined in the Purchase Agreement), Assignee will assume, observe, perform, fulfill and be bound by all terms, covenants, conditions and obligations of the Easements, Rights-of-Way, and Permits and the Other Easements, Rights-of-Way and Permits that arise on and after the Closing Time.
- 3. Terms of the Purchase Agreement. This Easement, Rights-of-Way, and Permit Assignment and Assumption Agreement has been delivered and accepted pursuant to the terms of the Purchase Agreement and is subject to all of the terms, provisions and conditions set forth in the Purchase Agreement, including, without limitation, those provisions relating to the survival of, and indemnification with respect to, the respective representations, warranties and covenants of Assignors and Assignee under the Purchase Agreement. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall control.
- 4. <u>Successors and Assigns</u>. The terms and conditions of this Easement, Rights- of-Way, and Permit Assignment and Assumption Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
- 5. <u>Governing Law</u>. This Easement, Rights-of-Way, and Permit Assignment and Assumption Agreement shall be governed by and construed in accordance with the internal laws of the State of Oregon without giving effect to any choice or conflict of law provision or rule (whether of the State of Oregon or any other jurisdiction).
- 6. <u>Counterparts</u>. This Easement, Rights-of-Way, and Permit Assignment and Assumption Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed

copy of this Easement, Rights-of-Way, and Permit Assignment and Assumption Agreement delivered by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Easement, Rights-of-Way, and Permit Assignment and Assumption Agreement.

- 7. <u>Further Assurances</u>. Subject to Section 5.7 of the Purchase Agreement, each of the parties hereto (at Assignee's sole cost and expense) shall execute and deliver, at the reasonable request of the other party hereto, such additional documents, instruments, conveyances and assurances and take such further actions as such other party may reasonably request to carry out the provisions hereof and give effect to the transactions contemplated by this Easement, Rights-of-Way, and Permit Assignment and Assumption Agreement.
- 8. Recording. Following execution and acknowledgement by all parties hereto, this instrument shall be recorded in the real property records of each of Deschutes, Jefferson, Crook and Klamath Counties, Oregon.




