THIS INDENTURE, Made this 9/15/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and US Bank National Association, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 120399CV, Klamath County Sheriff's Office Number J13-0145, in which US Bank National Association was plaintiff(s) and Arthur D. Warren and Juliet Franklin, et al was defendant(s), in which a Writ of Execution of Real Property: Foreclosure, which was issued on 12/6/2013, directing the sale of that real property, pursuant to which, on 2/19/2014 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$18,000.00, to US Bank National Association, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 

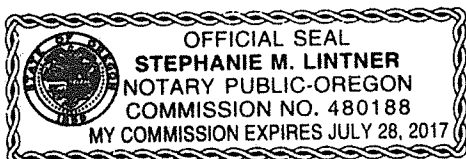


