THE SECRETARY OF VETERANS AFFAIRS, an Officer of the United States of America, whose address is Department of Veterans Affairs, 810 Vermont Avenue NW, Washington, DC 20420 hereinafter referred to as **GRANTOR**, does hereby grant, bargain, sell, convey unto RHONDA NEIGHORN, hereinafter referred to as **GRANTEE(S)**, the following lands and property:

GRANTOR does for Grantor and Grantor's heirs, personal representatives, executors and assigns hereby covenant with GRANTEE that Grantor is lawfully seized in fee simple of said premises.

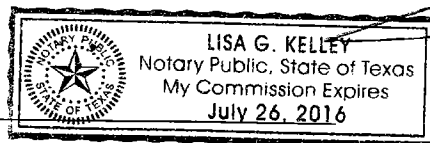
