THIS INDENTURE, Made this 9/16/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association, hereinafter called the grantee;

WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1301590CV, Klamath County Sheriff's Office Number J13-0152, in which JPMorgan Chase Bank, National Association was plaintiff(s) and Lynell Pool, individually and as constructive trustee of the Estate of Patricia L. Pool; United States of America; unknown heirs of Patricia L. Pool, other persons or parties, including occupants, unknown claiming any right, title, lien, or interest in the property described in the complaint herein was defendant(s), in which a Writ of Execution, which was issued on 12/12/2013, directing the sale of that real property, pursuant to which, on 2/21/2014 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$87,001.12, to JPMorgan Chase Bank, National Association, who was the highest and best bidder, that sum being the highest and best sum bid therefore. At the time of the sale, the purchaser paid the amount bid for the property to the grantor or grantor's predecessor in office. 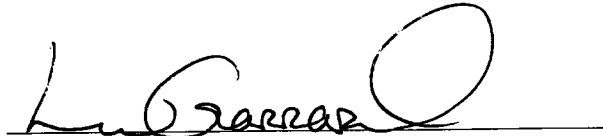

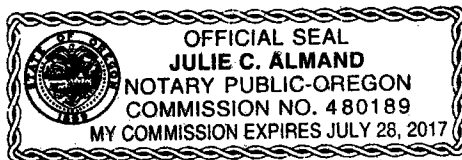

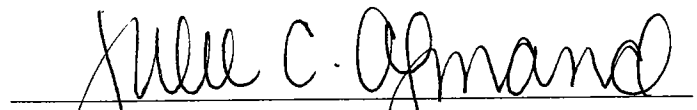
