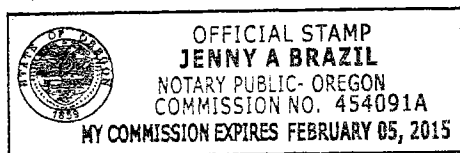

## EXHIBIT "A"

### LEGAL DESCRIPTION

All that portion of the canal or ditch known as the "Upper Dry Lake Lateral No.2" lying within the West half of Section 5, Township 40 South, Range 13 East, Willamette Meridian, County of Klamath, State of Oregon, being a forty five foot wide strip of land lying twenty five feet on the easterly side and twenty feet on the westerly side of the line, more particularly described as follows:

Beginning at a point on the easterly right of way line of the "Upper Dry Lake Lateral No.2", from which the West Quarter Corner of said Section 5 bears the following six courses:

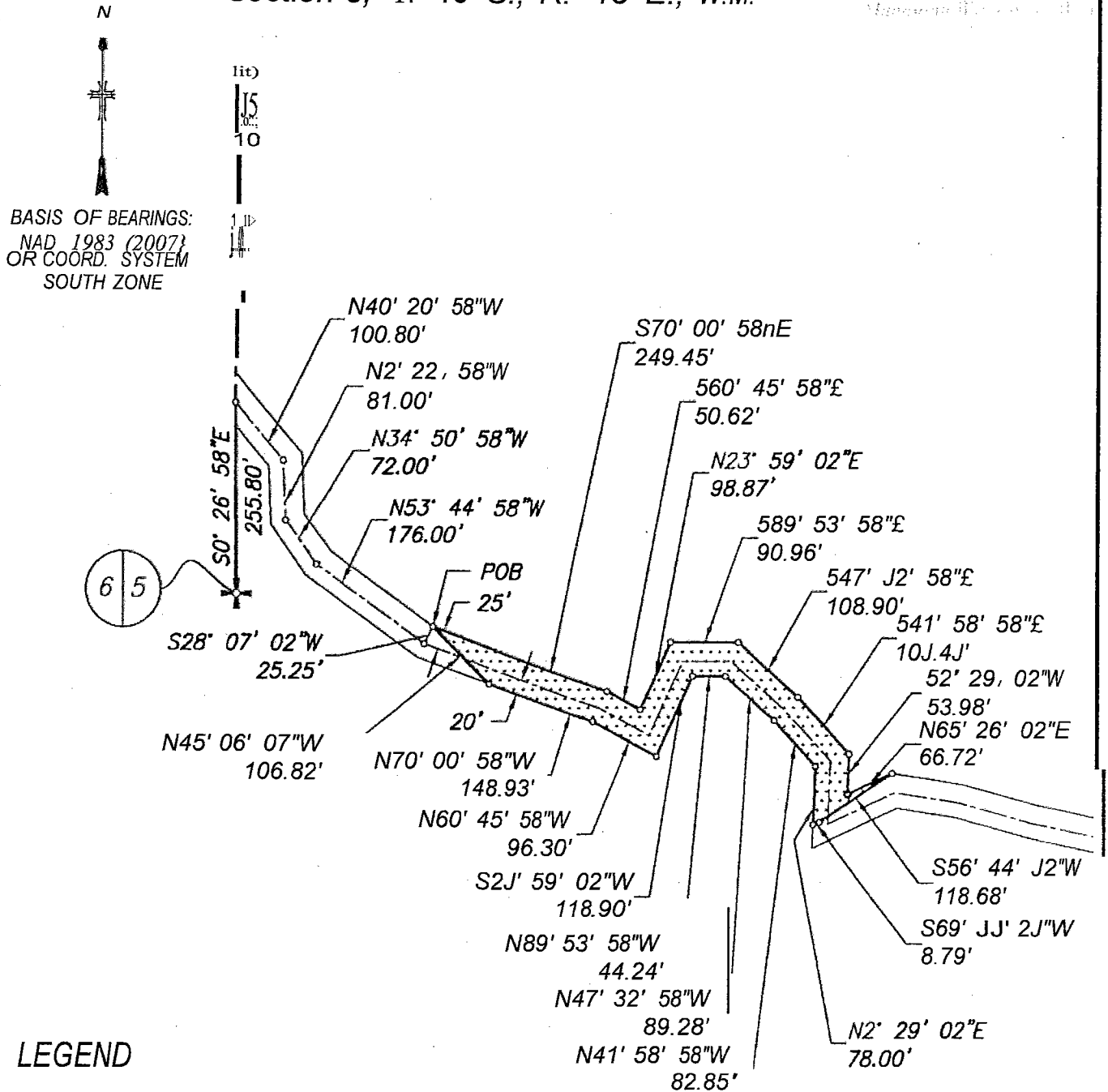
