#### **MODIFICATION OF DEED OF TRUST**

This Modification of Deed of Trust (this "Modification") is entered into as of September 17, 2014, by and between TERRI LEE LAWRENCE AND ROBERT HOWARD LAWRENCE, as Tenants by the Entirety ("Grantor") located at 35443 S Chiloquin Rd, Chiloquin, OR 97624, and WELLS FARGO BANK, NATIONAL ASSOCIATION ("Beneficiary"), with an office located at 1300 SW 5<sup>th</sup> Avenue, 11<sup>th</sup> Floor Portland, OR 97201.

## **RECITALS**

This Modification is entered into upon the basis of the following facts and understandings of the parties:

- A. This Modification pertains to that certain Deed of Trust dated as of June 18, 2004, executed by Grantor to Wells Fargo Financial National Bank, as Trustee, in favor of Beneficiary, and recorded on June 29, 2004, in volume No. M04 at page 42315-334, of the Records of Klamath County, Oregon, as may have been modified from time to time ("Deed of Trust").
- B. The obligations secured by the Deed of Trust have been modified, or certain additional obligations have been or are to be incurred which are to be secured by the Deed of Trust, or other modifications to the Deed of Trust have become necessary, and Grantor and Beneficiary have agreed to modify the Deed of Trust to accurately reflect the obligations as secured thereby or such other modifications.

NOW, THEREFORE, the parties hereto agree as follows:

1. The Deed of Trust is hereby modified to include within the indebtedness and obligations secured by the Deed of Trust, the payment to Beneficiary of all indebtedness and performance of all obligations evidenced by and arising under that promissory note, loan or credit agreement, confirmation letter and disclosure, or other evidence of debt, dated as of September 17, 2014, evidencing indebtedness of TERRI LEE LAWRENCE AND ROBERT HOWARD LAWRENCE to Beneficiary in the principal amount of \$83,515.02, with a final maturity date of June 25, 2017 (which represents the refinancing of that certain promissory, loan or credit agreement, confirmation letter and disclosure, or other evidence of debt, dated as of June 18, 2004, and secured by the Deed of Trust), together with

interest thereon, and any such indebtedness or other obligations incurred under or in connection with the credit accommodation evidenced, even if not specifically referenced therein.

- 2. The real property and the whole thereof described in the Deed of Trust shall remain subject to the lien, charge or encumbrance of the Deed of Trust and nothing herein contained or done pursuant hereto shall affect or be construed to affect the liens, charges or encumbrances of the Deed of Trust, or the priority thereof over other liens, charges or encumbrances, or to release or affect the liability of any party or parties who may now or hereafter be liable under or on account of said promissory notes, loan or credit agreements, confirmation letters and disclosures, or other evidences of debt and/or the Deed of Trust.
- 3. All terms and conditions of the Deed of Trust not expressly modified herein remain in full force and effect, without waiver or amendment. This Modification and the Deed of Trust shall be read together, as one document.


