THIS INDENTURE, Made this 10/7/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Ocwen Loan Servicing, LLC, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1203883CV, Klamath County Sheriff's Office Number J14-0006, in which Ocwen Loan Servicing, LLC, its successors in interest and/or assigns was plaintiff(s) and Unknown Heirs of Michael A. Gehon; Sandra Lee Gehon; Nicholas Anthony Gehon; occupants of the premises; and the real property located at 215 North Willow Street, Merrill, Oregon 97633 was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 12/11/2013, directing the sale of that real property, pursuant to which, on 3/14/2014 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$30,075.00, to Ocwen Loan Servicing, LLC, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 


