THIS INDENTURE, Made this 10/20/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Pacific Crest Federal Credit Union, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1300377CV, Klamath County Sheriff's Office Number J14-0059, in which Pacific Crest Federal Credit Union, its successors in interest and/or assigns was plaintiff(s) and Steven F. Haudenschild, and Beverly J. Devry; Capital One Bank (USA) N.A. and Occupants of the Premises was defendant(s), in which a Writ of Execution, which was issued on 4/10/2014, directing the sale of that real property, pursuant to which, on 7/7/2014 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$109,148.14, to Pacific Crest Federal Credit Union, who was the highest and best bidder, that sum being the highest and best sum bid therefore. At the time of the sale, the purchaser paid the amount bid for the property to the grantor or grantor's predecessor in office. TO HAVE AND TO HOLD the same unto the grantee and grantee's heirs, successors, and assigns forever.

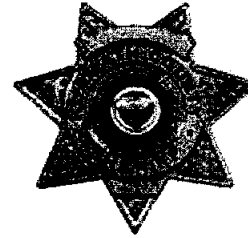
