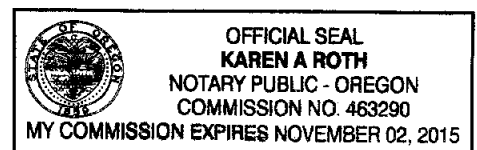


EXHIBIT A

A parcel of land, containing 11.1 acres, more or less, situated in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 30, T. 39 S., R. 11 E., W.M., in Klamath County, Oregon; being more particularly described as follows:

Beginning at a $\frac{1}{2}$ " rebar at the southeast corner of the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 30;

thence N 00° 15' 18" E--918.16 feet, along the East line of the SW $\frac{1}{4}$ NE $\frac{1}{4}$, to a $\frac{1}{2}$ " rebar;

thence N 89° 57' 22" W--505.94 feet to a $\frac{1}{2}$ " rebar on the left bank of Lost River;

thence, continuing N 89° 57' 22" W--125 feet, more or less, to the centerline of Lost River;

thence Southerly, along the centerline of Lost River, to the South line of the SW $\frac{1}{4}$ NE $\frac{1}{4}$;

thence S 89° 57' 06" E--125 feet, more or less, to a $\frac{1}{2}$ " rebar on the left bank of Lost River;

thence, continuing S 89° 57' 06" E--599.17 feet, along the South line of the SW $\frac{1}{4}$ NE $\frac{1}{4}$, to the point of beginning.
