The true and actual consideration for this conveyance is **\$67,500.00**.

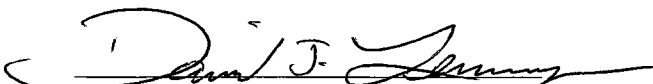

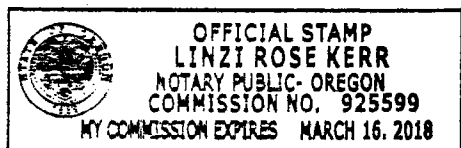
