**NOTICE OF DEFAULT AND ELECTION TO SELL**

KNOW ALL MEN BY THESE PRESENTS, that RYAN B. WEIDER, is the grantor, and AMERITITLE, INC., Is the trustee, and ERSKINE DELOE is the beneficiary under that certain trust deed dated March 9, 2006, and recorded on March 14, 2006, in Volume No. M-06 at page 004577 of the Mortgage (Microfilm) Records of Klamath County, Oregon. The property is described as:

All of Blocks 19, 22 and 23 of KLAMATH HEIGHTS, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

The undersigned hereby certifies that no assignments of the trust deed by the trustee or by the beneficiary and no appointments of a successor-trustee have been made except as recorded in the mortgage records of the county or counties in which the above described real property is situate; further, that no action has been instituted to recover the debt, or any part thereof, now remaining secured by the said trust deed, or, if such action has been instituted, such action has been dismissed.

There is a default by the grantor or other person owing an obligation, the performance of which is secured by said trust deed, or by their successor in interest, with respect to provisions therein which authorize sale in the event of default of such provision; the default for which foreclosure is made is grantor's failure to pay when due the following sums:
