RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1203147CV, Klamath County Sheriff's Office Number J14-0038, in which Wells Fargo Bank, N.A. was plaintiff(s) and DEBORAH GREENFIELD, INDIVIDUALLY AND AS CONSTRUCTIVE TRUSTEE OF THE ESTATE OF BETTIE R. 
