1. On the 11th day of December, 2014, a foreclosure sale occurred pursuant to a trust deed in which Scott M. Olsen and Jaime L. Olsen, as grantors, conveyed to Amerititle, as trustee, certain real property in Klamath County, Oregon, which trust deed was dated July 24, 2006, and recorded on July 25, 2006, in the mortgage records of said county, as Document No. M06-14915. 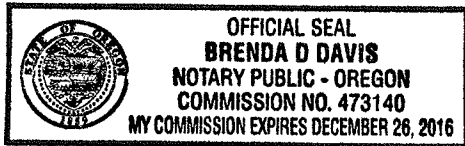
