MEMORANDUM OF LAND LEASE AGREEMENT

This MEMORANDUM OF LAND LEASE AGREEMENT ("Memorandum") is made this 4th day of (1111), 2013 between Erin Leigh Thompson, Stanley J. Pence Sr. and Beverly A. Pence, hereinafter referred to as "LESSOR", and Verizon Wireless (VAW) LLC d/b/a Verizon Wireless, hereinafter referred to as "LESSEE". LESSOR and LESSEE are at times collectively referred to hereinafter as the "Parties" or individually as the "Party".

- 1. LESSOR and LESSEE entered into that certain Land Lease Agreement dated October 19, 2006 (the "Lease") whereby LESSEE leased from LESSOR a portion of that certain property located in Klamath County, State of Oregon (the "Property) (which Property is legally described in Exhibit "A" attached hereto).
- 2. LESSOR and LESSEE have entered into that certain First Amendment to Land Lease Agreement dated <u>(Crtolus</u>, 2013 ("First Amendment") and now desire to evidence the Lease, as amended.
- 3. The Lease is currently set to expire on July 31, 2013. Following the expiration of the current term, the Lease shall automatically be extended for six (6) additional, successive five (5) year extension terms unless LESSEE notifies LESSOR, in writing, of LESSEE'S intention not to renew at least thirty (30) days prior to the end of the then current term.
- 4. This Memorandum is not intended to amend or modify, and shall not be deemed or construed as amending or modifying, any of the terms, conditions or provisions of the Lease, all of which are hereby ratified and affirmed. In the event of a conflict between the provisions of this Memorandum and the provisions of the Lease, the provisions of the Lease shall control. The terms, covenants and provisions of the First Amendment, the terms of which are hereby incorporated by reference into this Memorandum, shall extend to and be binding upon the respective executors, administrators, heirs, successors and assigns of LESSOR and LESSEE.
