## LEGAL DESCRIPTION OF THE LAND

A tract of land situated in the North one-half of Section 22, Township 39 South, Range 9 East, Willamete Meridian, Klamath County, Oregon, being more particularly described as follows:

Beginning at a point from which the Northeast corner of said Section 22 bears North 63°55'53" East, 2,058.49 feet; thence South 00°00'00" West 263.49 feet; thence North 90°00'00" East, 100.00 feet; thence South 00°00'00" West, 193.99 feet; thence North 90°00'00" West, 143.36 feet to a point of non-tangent curvature; thence along the arc of a 485.00 foot radius non-tangent curve to the left, through a central angle of 35°58'23", an arc distance of 304.51 feet (the long chord of which bears North 72°00'48" West, 299.53 feet) to a point of tangency; thence North 90°00'00" West 331.44 feet; thence North 03°30'27" West, 36.49 feet to a point of curvature; thence along the arc of a 450.00 foot radius curve to the left, through a central angle of 33°11'24", an arc distance of 260.67 feet (the long chord of which bears North 20°06'10" West, 257.05 feet) to a point of tangency; thence North 36°41'52" West, 75.51 feet; thence North 00°00'00" East, 26.63 feet; thence North 90°00'00" East, 795.40 feet to the point of beginning.
