EXHIBIT "A" LEGAL DESCRIPTION

A parcel of land lying in the E1/2 NE1/4 NE1/4 of Section 1, Township 24 South, Range 6 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at the intersection of the Westerly right of way line of Highway #58 and the Southerly right of way line of Secondary Highway #429 (Crescent Lake Road), which lies South 25° 53' West a distance of 493 feet and South 16° 19' East a distance of 30 feet and South 74° 00' West a distance of 40 feet from the Northeast corner of said Section 1, Township 24 South, Range 6 East of the Willamette Meridian, Klamath County, Oregon; thence continuing South 16° 19' East, along the Westerly right of way line of Highway #58, a distance of 170 feet to the true point of beginning of this description; thence South 74° 00' West, parallel with the Southerly line of the Crescent Lake Road, a distance of 140 feet; thence South 16° 19' East, parallel with the Westerly line of Highway #58, a distance of 175 feet; thence North 74° 00' East a distance of 140 feet to the Westerly right of way line of Highway #58, a distance of 175 feet, more or less, to the point of beginning, in Klamath County, Oregon.
