## BARGAIN AND SALE DEED

JAMES BLAKE OWENS, Grantor, conveys to OREGON TECH FOUNDATION, INC., an Oregon nonprofit corporation, Grantee, the real property situated in Klamath County, Oregon, described on the attached Exhibit A (the "Property"), SUBJECT to the following restrictions and obligations:

- 1. Grantor reserves to himself the exclusive use, possession, and enjoyment of the Property and the rents, issues, and profits therefrom during his natural lifetimes.
- 2. In making this conveyance, Grantor intends to make an irrevocable contribution to Grantee of a vested remainder interest in their property within the meaning of Section 170(f)(3)(B)(i) of the Internal Revenue Code of 1986 and the regulations promulgated thereunder, and to obtain the full benefit of any income gift and estate tax charitable deductions to which Grantor or his estate may be entitled. This deed and the conveyance, rights and obligations set forth herein shall be interpreted consistent with Grantor's intent.
- 3. Consistent with Grantor's intent to contribute to Grantee an irrevocable remainder interest in the Property, reserving a life estate therein, Grantor agrees to keep the Property in good condition and repair, to refrain from committing or permitting waste, to pay all taxes, liens, and assessments promptly when due, to keep any improvements on the Property adequately insured against loss or damage by fire or other casualty, to make all reasonable efforts to retain all existing water rights, and generally to comply with all the obligations of a life tenant.

The true consideration for this conveyance is \$0. However, the actual consideration consists of or includes other property or value given or promised.
