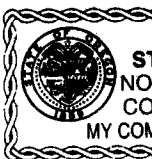

THIS INDENTURE, Made this 12/23/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association (FNMA), hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1301736CV, Klamath County Sheriff's Office Number J13-0135, in which JPMorgan Chase Bank, National Association was plaintiff(s) and Alma D. Robles; Mortgage Electronic Registration Systems, Inc.; Greenpoint Mortgage Funding, Inc.; Occupants of the property was defendant(s), in which a Writ of Execution, which was issued on 10/30/2013, directing the sale of that real property, pursuant to which, on 4/11/2014, the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$171,478.01, to JPMorgan Chase Bank, National Association, who was the highest and best bidder, that sum being the highest and best sum bid therefore. At the time of the sale, the purchaser paid the amount bid for the property to the grantor or grantor's predecessor in office. After Grantor received funds in the amount bid at the sale, a certificate of sale, as required by law, was duly executed and delivered to the purchaser.

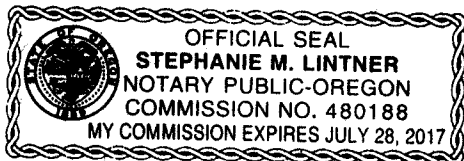


