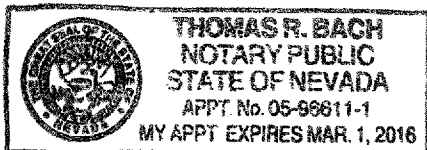

**ESTOPPEL AFFIDAVIT**

Yubeldena Bond, (the "Affiant") being first duly sworn, deposes and states:

That the Affiant is the individual who made, executed, and delivered that certain Warranty Deed (Deed in Lieu) to Federal Home Loan Mortgage Corporation, conveying the following described property ("Property") in Klamath County, Oregon.

Lots 9 and 10 in Block 14 of First Addition to Bly, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Tax Parcel No.: 406064

Commonly known as 61017 Protsman Street, Bly, Oregon 97622

That the aforesaid Warranty Deed is intended to be and is an absolute conveyance of the title to the Property to the Grantee named therein, and was not and is now not intended as a mortgage, trust conveyance, or security of any kind; that it was the intention of Affiant as Grantor of the Warranty Deed to convey, and by the Warranty Deed the Affiant did convey, to the Grantee therein all right, title, and interest absolutely in and to the Property; and that possession of the Property has been surrendered to the Grantee;

That in the execution and delivery of the Warranty Deed, Affiant as Grantor was not acting under any misapprehension as to the effect thereof, and acted freely and voluntarily and was not acting under coercion or duress;

That the Warranty Deed shall not cause a merger of the Affiant's interest under the Warranty Deed with the Beneficiary's interest under the Deed of Trust encumbering the Property and granted by Affiant herein, to Aspen Title & Escrow as Trustee, and to Mortgage Electronic Registration Systems, Inc. ("MERS"), as nominee for America's Wholesale Lender, its successors and assigns as Beneficiary, dated April 25, 2006, and recorded on May 2, 2006, under File No. M06-08576, in the Official Records of Klamath County, State of Oregon (the "Deed of Trust") and assigned to Bank of America, N.A., successor by merger to BAC Home Loans Servicing, LP fka Countrywide Home Loans Servicing LP by way of Assignment of Deed of Trust recorded on October 24, 2011 under File No. 2011-011841, described herein, or the related documents. The interest transferred by the Warranty Deed is intended to be a separate interest from the beneficial interest or lender's interest under the Deed of Trust.

The Warranty Deed was not, and is not given as a preference against any other creditors of the Affiant herein; there is no other person or persons, firms or corporations, other than the Affiants therein named interested, either directly or indirectly in said Property; that Grantor is solvent and has no other creditors whose rights would be prejudiced by such conveyance and that Grantor is not obligated upon any bond or other deed of trust whereby any lien has been created or exists against the Property described in said Warranty Deed.

Consideration for the Warranty Deed is payment to Affiant of the sum of \$0.00 by Grantee, and a covenant not to sue to enforce the promissory note dated April 25, 2006, in the amount of \$58,800.00, or to foreclose the Deed of Trust encumbering the Property; that at the time of

making the Warranty Deed, Affiant believed and now believes that this consideration represents the fair value of the Property so deeded.

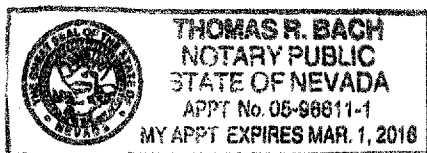
