TITLE Policy for Collection of Delinquent Assessments

This matter coming before the OSBC Board at a regular meeting and it appearing that the several Directors were afforded ample opportunity to weigh and discuss the issue, and a quorum being present:

Now, THEREFORE, IT IS HEREBY RESOLVED:

An outline of Oregon Shores Beach Club (OSBC) procedure for the collection of delinquent assessments is as follows:

- 1. May 15th—OSBC mails out the annual assessment dues
- 2. July 1st—The annual lot assessments are due
- 3. October 1st—Lot assessments that are unpaid are deemed delinquent and a late charge of \$10 per lot is assessed per OSBC resolution 001-14.
- 4. November 1st—Lot assessments still not paid in full (including late fees) are assessed an additional \$25 per lot (total of \$35 per lot in late fees) per OSBC resolution 001-14.
- 5. December 1st— Lot assessments still not paid in full (including late fees) are assessed an additional \$50 per lot (total of \$85 per lot in late fees) per OSBC resolution 001-14.
- 6. January—The OSBC Board of Directors reviews the list of delinquent accounts.
- 7. January—All delinquent accounts which are two (2) years or more overdue (and not making monthly payments) will either be taken to small claims court (and court fees will be assessed in addition to the late fees) or be turned over to the OSBC attorney. When accounts are turned over to the attorney, an additional 9% fee will be assessed (in addition to the late fees).
