THIS INDENTURE, Made this 1/28/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and JPMorgan Chase Bank, National Association, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1302625CV, Klamath County Sheriff's Office Number J14-0048, in which JPMorgan Chase Bank, National Association was plaintiff(s) and Archie B. Smith; Victoria Klingberg Smith; U.S. Bank, National Association; State of Oregon, other persons or parties, including occupants, unknown claiming any right, title, lien, or interest in the property described in the complaint herein was defendant(s), in which a Writ of Execution, which was issued on 3/7/2014, directing the sale of that real property, pursuant to which, on 6/4/2014 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$100,869.72, to JPMorgan Chase Band, National Association, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 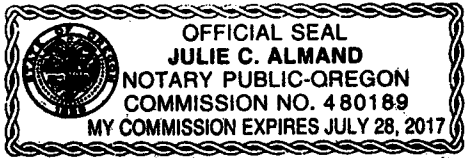
