THIS INDENTURE, Made this 1/27/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Green Tree Servicing LLC, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1301227CV, Klamath County Sheriff's Office Number J14-0046, in which Green Tree Servicing LLC, its successors in interest and/or assigns was plaintiff(s) and Hugh Douglas Hite; West Hills Homes, Inc.; and occupants of the premises was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 3/3/2014, directing the sale of that real property, pursuant to which, on 6/4/2014 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$226,476.95, to Green Tree Servicing LLC, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 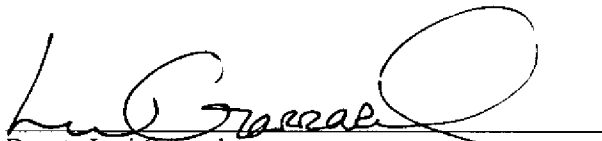

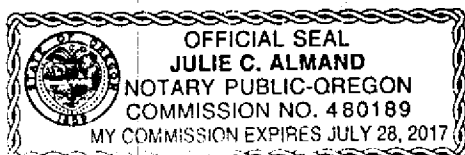

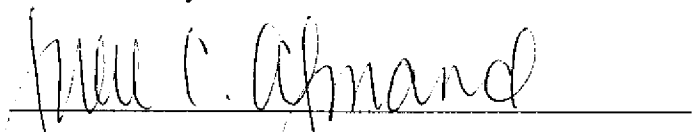
