RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1203205CV, Klamath County Sheriff's Office Number J14-0047, in which CITIMORTGAGE, INC., ITS SUCCESSORS IN INTEREST AND/OR ASSIGNS was plaintiff(s) and DENNIS L. GULLEY AKA DENNIS LEE GULLEY; ANITA E. GULLEY AKA ANITA ELAINE GULLEY; JENNIFER K. FOWLER FKA JENNIFER K. GULLEY; CHRISTOPHER C. 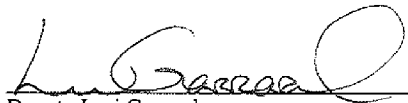

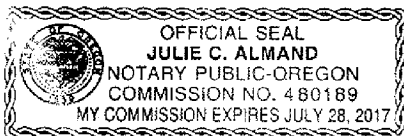

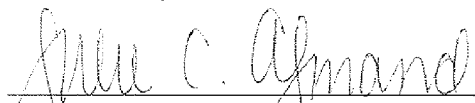
