THIS INDENTURE, Made this 1/29/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Green Tree Servicing, LLC, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1302932CV, Klamath County Sheriff's Office Number J14-0056, in which Green Tree Servicing, LLC, its successors and/or assigns was plaintiff(s) and BOBBY KINCAID; ALL OTHER PERSONS OR PARTIES UNKNOWN CLAIMING ANY RIGHT, TITLE, LIEN, OR INTEREST IN THE REAL PROPERTY COMMONLY KNOWN AS 2008 MADISON STREET, KLAMATH FALLS, OR 97603 was defendant(s), in which a Writ of Execution, which was issued on 3/31/2014, directing the sale of that real property, pursuant to which, on 6/9/2014 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$118,708.76, to Green Tree Servicing, LLC, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 

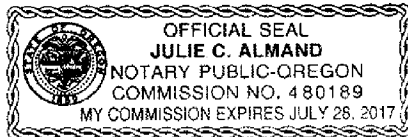


