Ritthaler, Co-Trustees of The Ritthaler Family Trust dated February 12, 2015, hereinafter called the Grantee, and to Grantee's heirs, successors and assigns, Grantors' interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belong or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:


The true and actual consideration paid for this transfer, stated in terms of dollars, is other than money.

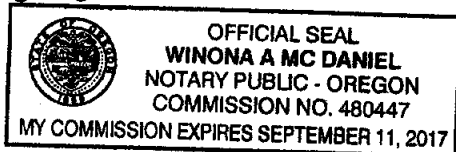

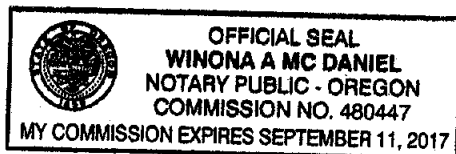
