THIS INDENTURE, Made this 1/29/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and PHH Mortgage Corporation, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1203563CV, Klamath County Sheriff's Office Number J14-0044, in which PHH Mortgage Corporation FKA Cendant Mortgage Corporation was plaintiff(s) and Arthur L. Sizemore; Glenda J. Sizemore; Premier Finance; and Occupants of the Premises was defendant(s), in which a Writ of Execution, which was issued on 3/5/2014, directing the sale of that real property, pursuant to which, on 6/2/2014 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$71,294.18, to PHH Mortgage Corporation, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 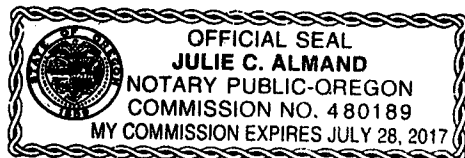

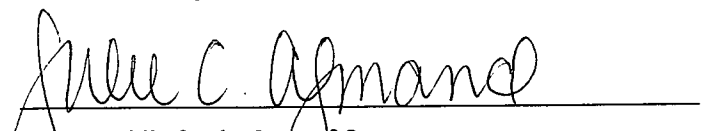
