Reference Memorandum of Land Sale Agreements 2011-006824 and 2011-006825 WHEREAS, Raymond M Kahut entered into two land sale agreements with Klamath County on June 3, 2011 for the purchase of real properties described as:

Lot 47, Block 29, Oregon Shores Unit 2 Tract 1113 and Lot 50, Block 24, Oregon Shores Unit 2 Tract 1113. Also known as R-3507-17CB-5300/R237247 and R-3507-18DA-5100/R245461.

All according to the official plats thereof on the file in the office of the County Clerk of Klamath County, Oregon; and shall Subject to Covenants, conditions, restrictions, easements, reservations, rights of way and all matters appearing of record.

WHEREAS, these real properties were purchased for the sum of \$7,400. Down payments received were \$1,924 plus \$74 for recording fees. Annual installments paid in the sum of \$1,665.

NOW, THEREFORE, IT IS HEREBY ORDERED, the Klamath County Board of Commissioners directs the Klamath County Tax Collector to cancel the land sale agreements with Raymond M Kahut on the referenced properties, transferring ownership back into Klamath County's name.
