THIS INDENTURE, Made this 3/2/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and CitiMortgage, Inc., hereinafter called the grantee;

WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1204322CV, Klamath County Sheriff's Office Number J14-0093, in which CITIMORTGAGE, INC., ITS SUCCESSORS IN INTEREST AND/OR ASSIGNS was plaintiff(s) and EARLA MAE PATTON AKA EARLA M. PATTON; LONDON A. MILLETT; AND OCCUPANT OF THE PREMISES was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 5/9/2014, directing the sale of that real property, pursuant to which, on 7/23/2014 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$26,124.84, to CitiMortgage, Inc., who was the highest and best bidder, that sum being the highest and best sum bid therefore. 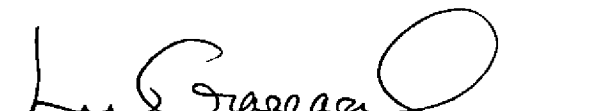

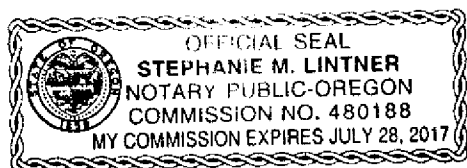

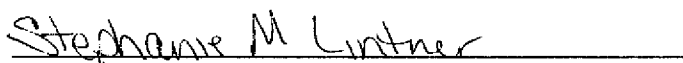
