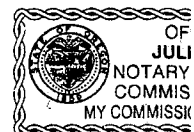

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case



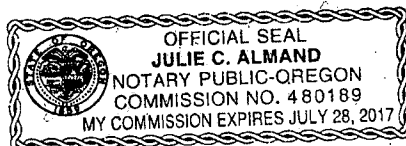


