RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1302523CV, Klamath County Sheriff's Office Number J14-0103, in which NATIONSTAR MORTGAGE LLC was plaintiff(s) and MEL T. MULLANEY, INDIVIDUALLY AND AS SUCCESSOR IN INTEREST TO PATRICIA A. 




