RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1300976CV, Klamath County Sheriff's Office Number J14-0073, in which NATIONSTAR MORTGAGE LLC was plaintiff(s) and LAURIE CHAVARRIA; TRAVIS DEVRY; STATE OF OREGON DEPARTMENT OF REVENUE; SOUTH VALLEY BANK & TRUST; STERLING SAVINGS BANK; KIMBERLY FRANKLIN; OCCUPANTS OF THE PROPERTY was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 4/18/2014, directing the sale of that real property, pursuant to which, on 7/14/2014 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$229,775.01, to Nationstar Mortgage LLC, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 

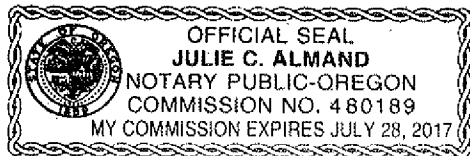


