## ASSIGNMENT OF TRUST DEED BY BENEFICIARY TEMUJIN K, F, MAH

- 3. The undivided one-third (1/3<sup>rd</sup>) interest of Temujin K. F. Mah having then been assigned to the undersigned by that certain Assignment of Trust Deed by Beneficiary Temujin K. F. Mah dated the 5<sup>th</sup> day of March, 2015, and recorded on the 6th day of March, 2015, as Instrument No. 2015-002010 of the Official Records of Klamath County, Oregon, wherein the Estate of Temujin K. F. Mah was assignor and Ngar Chun Mah was assignee, as to an undivided one-third (1/3) interest as beneficiary; said Trust Deed conveying real property in the state of Oregon, Klamath County, described as follows, to-wit:

hereby grants, assigns, transfers, and sets over to NGAR CHUN MAH, TRUSTEE OF THE TEMUJIN KIN FIN MAH AND NGAR CHUN MAH REVOCABLE LIVING TRUST, U.A.D. 05-19-2014, hereinafter called Assignee, one hundred percent (100%) interest of the one-third (1/3<sup>rd</sup>) interest of NGAR CHUN MAH, and to Assignee's heirs, personal representatives, successors and assigns, all of the beneficial interest of NGAR CHUN MAH in and under the Trust Deed, together with the notes, moneys and obligations therein described or referred to, with the interest thereon, and all rights and benefits whatsoever accrued or to accrue to NGAR CHUN MAH under the Trust Deed.

The undersigned hereby covenants to and with the Assignee that the undersigned is beneficiary NGAR CHUN MAH's successor in interest under the Trust Deed and is the owner and holder of NGAR CHUN MAH's beneficial one-third (1/3<sup>rd</sup>) interest thereon and has the right to sell, transfer and assign the same, and the note or other obligation secured thereby. There is now unpaid on the obligations secured by the Trust Deed the sum of not less than \$88,360.61 with interest thereon at the rate of 6.750% per annum from February 19, 2015.

In construing this instrument, whenever the context so requires, the singular includes the plural and vice-versa.
