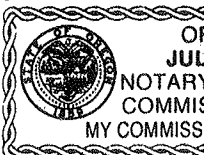

THIS INDENTURE, Made this 3/4/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal Home Loan Mortgage Corporation, hereinafter called the grantee; WITNESSETH:



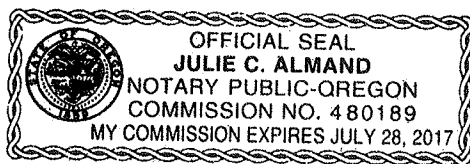


