



## EXHIBIT A

That land located in Klamath County, Oregon, conveyed by Patent from the United States on August 16, 1951, which is more particularly described as follows:

**Lots four and six, and the southwest quarter of the northeast quarter of section twenty-two in township forty-one south of range twelve east of the Willamette Meridian, Oregon, containing 81.15 acres, according to the Official Plats of the Survey of the said lands on file in the Bureau of Land Management, Department of the Interior.**

LESS AND EXCEPTING THEREFROM the following described portion of Government Lot 4:

Beginning at the North  $\frac{1}{4}$  Corner of Section 22; Thence S  $4^{\circ} 30' 00''$  E along the West line of Government Lot 2, 396.00 feet more or less to the Southwest Corner of Government Lot 2, said point is also the Northwest Corner of Government Lot 4; Thence N  $70^{\circ} 15' 00''$  W along the extended South line of Government Lot 2, 33.01 feet more or less to the East line of the Northeast  $\frac{1}{4}$ , of the Northwest  $\frac{1}{4}$ , of Section 22; Thence North along the East line of the Northeast  $\frac{1}{4}$ , of the Northwest  $\frac{1}{4}$ , of Section 22, 383.62 feet, more or less, to the point of Beginning.
