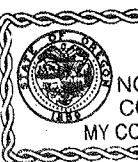

THIS INDENTURE, Made this 3/4/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1302632CV, Klamath County Sheriff's Office Number J14-0020, in which BANK OF AMERICA, N.A. was plaintiff(s) and MICHAEL L. SCHULTE; JI & MS LLC; BANK OF AMERICA, N.A. 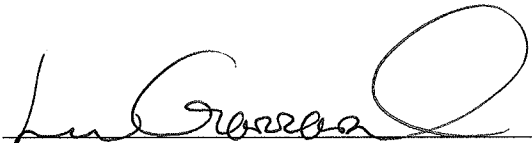

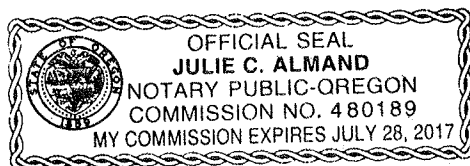

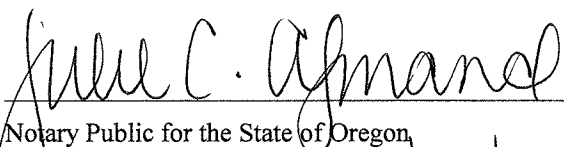
