THIS INDENTURE, Made this 3/2/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Nationstar Mortgage LLC, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1204374CV, Klamath County Sheriff's Office Number J14-0072, in which NATIONSTAR MORTGAGE LLC, ITS SUCCESSORS IN INTEREST AND/OR ASSIGNS was plaintiff(s) and SHARON L. 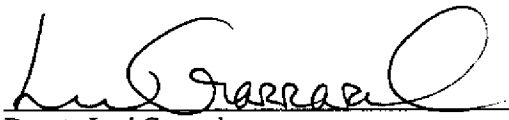

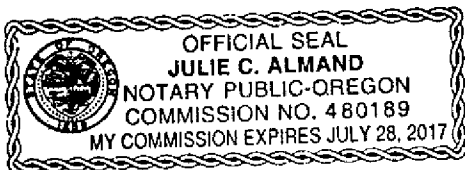

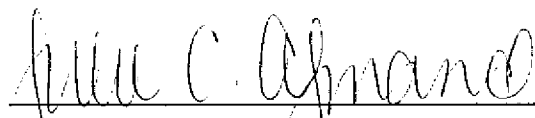
